



CONSENT ORDER AND STIPULATION

STIPULATION

Respondent acknowledges the facts and violations of the Public Health Code, 1978 PA 368, as amended; MCL 333.1101 et seq, as set forth in the Administrative Complaint and voluntarily waives the opportunity to show compliance, to have a hearing, to be represented by an attorney, and to have the appearance of witnesses; and agrees to the sanctions set forth in the following Consent Order (Order).

Complainant and Respondent agree that the Disciplinary Subcommittee of the Michigan Board of Medicine may enter an order as stipulated above.

CONSENT ORDER

IT IS FOUND that Respondent violated Mich Admin Code, R 338.2371; Mich Admin Code, R 338.2373(1); Mich Admin Code, R 338.2381(2); and section 17033(1) of the Public Health Code, supra, which constitute violations of section 16221(h) of the Public Health Code, supra; accordingly,

IT IS ORDERED that Respondent is:

1. REPRIMANDED;
2. FINE of \$560.00 to be paid to the State of Michigan within 60 days from the effective date of this Order. The fine shall be mailed to the Department of Licensing and Regulatory Affairs, Enforcement Division, Sanction Monitoring, P.O. Box 30189, Lansing, MI 48909. The fine shall be paid by check or money order made

payable to the State of Michigan, and the check or money order shall clearly display file number 43-16-140270; and

3. Placed on PROBATION for a minimum of one day not to exceed one year, commencing on the effective date of this Order. During the probationary period, Respondent shall earn 36 hours of Board-approved category 1 continuing education credit. These 36 hours **shall not** apply in computing Respondent's current continuing education requirements for license renewal.

Proof of the successful completion of continuing education shall be mailed to the **Department of Licensing and Regulatory Affairs, Enforcement Division, Sanction Monitoring, P.O. Box 30670, Lansing, MI 48909.**

Respondent shall be automatically discharged from probation upon the Department's receipt of evidence of successful completion of 36 hours of Board-approved category 1 continuing education, provided Respondent has paid the fine, has complied with the terms of this Order, and has not violated the Public Health Code.

IT IS FURTHER ORDERED that this Order shall be effective on the date signed as set forth below.
