**REQUEST FOR LICENSE
INACTIVATION WITH CAUSE AND
ORDER INACTIVATING LICENSE
WITH CAUSE**

4 Holder of License No. 24079
5 For the Practice of Allopathic Medicine in the
6 State of Arizona.

7 1. I, Franc W. Brodar, M.D. ("Respondent"), am the holder of License No. 24079 to
8 practice allopathic medicine in the State of Arizona.

9 2. I hereby request that, effective at 5:00 p.m. on the date of the following Order,
10 the Arizona Medical Board ("Board") inactivate with cause my license to practice
11 allopathic medicine number 24079 pursuant to A.R.S. §32-1452(F). I participated in the
12 Board's Monitored Aftercare Program ("MAP"), currently referred to as the Physician
13 Health Program ("PHP"), between 2006 through 2011 and no longer qualify for a
14 confidential Board Order.

15 3. I will not practice medicine in Arizona or any other state, territory or district of the
16 United States or a foreign country while my Arizona license is inactive. I may not hold or
17 maintain a controlled substance certificate with the Drug Enforcement Administration or
18 write or refill prescriptions as long as my license is inactive. If I practice medicine while my
19 license is inactive I will be practicing medicine without a license and/or without being
20 exempt from licensure, which amongst other things, is a felony.

21 4. I shall not request reactivation of my license to practice medicine in Arizona until I
22 complete a long-term care residential program, an inpatient hospital treatment program,
23 an intensive outpatient treatment program, or any combination of these programs as
24 required by A.R.S. § 32-1452(F) and subsequently complete an assessment with the
25 Board's PHP Contractor, and the Board is in receipt of the assessment findings and

1 recommendations. I understand that I may also be required to complete other evaluations
2 if deemed necessary by the Board. The Board will not reactivate my license until I
3 present evidence satisfactory to the Board, in its sole discretion, that I am medically
4 competent and mentally and physically able to safely practice medicine in the State of
5 Arizona.

10 **FINDINGS OF FACT**

- 11 1. Respondent currently holds an active license to practice medicine in this state.
12 2. Respondent was under a Board stipulation or probationary order pursuant to
13 A.R.S. § 32-1452 that is no longer in effect.
14 3. On February 2, 2018, the Board received a self-report from Respondent stating
15 that he had experienced a relapse of his substance use disorder.
16 4. Pursuant to A.R.S. § 32-1452(F), Respondent has requested that his license to
17 practice medicine in the State of Arizona be placed on the status of Inactive with Cause.

18 **CONCLUSION OF LAW**

- 19 1. The Board possesses jurisdiction over the subject matter hereof and over
20 Licensee.
21 2. The conduct and circumstances described above constitute unprofessional
22 conduct pursuant to A.R.S. §32-1401(27)(f) ("[a] pattern of using or being under the
23 influence of alcohol or drugs or a similar substance while practicing medicine or to the
24 extent that judgment may be impaired and the practice of medicine detrimentally
25 affected.").

ORDER

IT IS HEREBY ORDERED THAT:

1. License number 24079 held by Respondent is Inactivated with Cause.
2. Before Respondent can request that his/her license be reactivated, he shall successfully complete a long-term care residential program, an inpatient hospital treatment program, an intensive outpatient treatment program or any combination of these programs as recommended by the Board's PHP Contractor and shall meet the applicable requirements of A.R.S. §32-1431(D).
3. Once Respondent has completed treatment, the Board shall determine if it should refer the matter for a formal hearing for the purpose of suspending or revoking the license or to place Respondent on probation for a minimum of five (5) years with restrictions necessary to ensure public safety.
